

Entry requirements

Version: 13.05.2021, applicable from 13.05.2021, further developments to be observed

1. Pre-Travel Clearance

- a. a. Before entering the country, people must register online at www.sozialministerium.at/PTC-Form-en and present the confirmation of transmission upon entry

2. Entries from EU / EEA countries, Switzerland, Andorra, Monaco, San Marino and the Vatican

- a. passengers arriving from one of the following countries AND who have only been to these countries or in Austria within the last 10 days are free to enter Austria (no molecular-biological test (PRC, LAMP or TMA) / Antigen-Test of SARS-CoV-2-test, no quarantine): Australia, Finland, Iceland, New Zealand, Republic Korea, Singapur, Vatican
- b. third-country nationals arriving from out of EU / EEA countries, Switzerland, Andorra, Monaco, San Marino and the Vatican or from out of countries as listed in a) are not allowed to enter Austria
- c. remaining persons are required to provide a negative molecular biological test (PRC, LAMP or TMA) not older than 72 hours / antigen not older than 48 h upon arrival or perform one within 24 h after arrival and start a 10-day quarantine, which is considered to have ended if a molecular biological test (PRC, LAMP or TMA) / antigen test for SARS-CoV-2 is carried out at the earliest on the fifth day after entry and the test result is negative
- d. exceptions apply to the following persons, although they must present a medical certificate¹ or a test result of a molecular biological test (PRC, LAMP or TMA) not older than 72 hours / antigen not older than 48 h and confirms that a molecular biological test (PRC, LAMP or TMA) / antigen test is negative for SARS-CoV-2:
 - i. humanitarian forces,
 - ii. people who come for work purposes,
 - iii. an accompanying person during entry for medical reasons,
 - iv. persons who enter the country for the purpose of performing a mandatory court or official duty, such as summoning to court hearings,
 - v. strangers, if they have a photo ID according to § 5 of the Official Seat Act - ASG, Federal Law Gazette I No. 54/2021.

If the medical certificate cannot be presented, a ten-day quarantine must be commenced immediately. If a molecular biological test (PRC, LAMP or TMA) / antigen test carried out during this time for SARS-CoV-2 is negative, the quarantine is deemed to have ended.

3. Entry from Germany

- a. passengers arriving from Germany AND who have only been to Germany or in Austria within the last 10 days can enter Austria without the obligation to start a quarantine, if they can provide:
 - i. a medical certificate or a test result of a molecular biological test (PRC, LAMP or TMA) not older than 72 hours / antigen not older than 48 h and confirms that a molecular biological test (PRC, LAMP or TMA) / antigen test is negative for SARS-CoV-2, OR
 - ii. a medical certificate or medical or official recovery certificate for an COVID-19-infection that has been overcome in the last six months, OR
 - iii. have a medical certificate or vaccination certificate for vaccination with a centrally approved vaccine against COVID-19, if the following conditions are met:
 - 1. from the 22nd day after the first vaccination, whereby this must not be more than three months ago, or
 - 2. second vaccination, whereby the first vaccination must not be more than nine months ago, or
 - 3. vaccination from the 22nd day after vaccination in the case of vaccines for which only one vaccination is planned, whereby this must not be more than nine months ago, or
 - 4. vaccination, provided there was a positive molecular biological test for SARS-CoV-2 at least 21 days before the vaccination or proof of neutralizing antibodies before the vaccination, whereby the vaccination must not be more than nine months ago

4. Entry from other states and areas

- a. passengers arriving from one of the following countries AND who have only been to these countries or in Austria within the last 10 days are free to enter Austria (no molecular-biological (PRC, LAMP or TMA) / Antigen-Test of SARS-CoV-2-test, no quarantine): Australia, Finland, Iceland, New Zealand, Norway, Republic Korea, Singapur, Vatican
- b. exceptions apply to the following people, who have to provide a negative molecular biological test (PRC, LAMP or TMA) not older than 72 hours / antigen not older than 48 h upon arrival or perform one within 24 h after arrival and enter a 10-day quarantine, which is considered to have ended if a molecular biological test (PRC, LAMP or TMA) / antigen test for SARS-CoV-

2 is carried out at the earliest on the fifth day after entry and the test result is negative:

- i. Austrian citizens, EU / EEA citizens and people who live with them in the same household,
 - ii. Swiss citizens as well as persons who live with them in the same household,
 - iii. people with residence or habitual abode in EU / EEA countries or Andorra, Monaco, San Marino, the Vatican or Switzerland and people who live with them in the same household,
 - iv. entry in connection with other important events that can be planned in the family circle such as weddings, baptisms, birthday parties or the non-regular visit of the partner,
 - v. foreigners, if they have a visa D issued by Austria or a photo ID according to § 5 of the Official Seat Act - ASG, Federal Law Gazette I No. 54/2021,
 - vi. persons who are entitled to stay in Austria on the basis of a residence permit, a residence title or documentation of the right of residence in accordance with the Settlement and Residence Act, Federal Law Gazette I No. 100/2005, or the Asylum Act 2005, Federal Law Gazette I No. 100/2005 are,
 - vii. persons who have a confirmation of the application pursuant to Art. 18 Para. 1 of the Agreement on the Withdrawal of the United Kingdom of Great Britain and Northern Ireland from the European Union and the European Atomic Energy Community (Withdrawal Agreement),
 - viii. members of the staff of diplomatic missions or consular posts and persons who live with them in the same household,
 - ix. employees of international organizations and people who live with them in the same household,
 - x. humanitarian forces,
 - xi. persons who are employed by a domestic regional authority or a domestic corporation under public law and whose place of employment is abroad or whose service is performed abroad, insofar as the activity of this corporation abroad is in the interests of the Republic of Austria,
 - xii. an accompanying person during entry for medical reasons,
 - xiii. people who enter the country for the purpose of performing a mandatory judicial or official obligation, such as summoning to court hearings
- c. exceptions apply to the following persons, although they must present a medical certificate¹ or test result of a molecular biological test (PRC, LAMP

or TMA) not older than 72 hours / antigen not older than 48 h and confirms that a molecular biological test (PRC, LAMP or TMA) / antigen test is negative for SARS-CoV-2:

- i. humanitarian forces,
- ii. people who come for work purposes,
- iii. an accompanying person during entry for medical reasons,
- iv. persons who enter the country for the purpose of performing a mandatory court or official duty, such as summoning to court hearings,
- v. strangers, if they have a photo ID according to § 5 of the Official Seat Act - ASG, Federal Law Gazette I No. 54/2021.

5. Entry from virus-variant-areas (Brazil, India and South Africa)

valid for passengers who have been in these countries in the last 10 days: Brazil, India or South Africa

- a. deviating from 3. exceptions apply to the following people, who have to provide a negative molecular biological test (PRC, LAMP or TMA) not older than 72 hours upon arrival (for Austrian, EU/EEA, Swiss citizens or people with a place of residence or habitual abode in Austria: or perform one within 24 h after arrival) and enter a 10-day quarantine, which is considered to have ended if a molecular biological test (PRC, LAMP or TMA) is carried out at the earliest on the fifth day after entry and the test result is negative:
 - i. Austrian citizens, EU / EEA citizens and people who live with them in the same household,
 - ii. Swiss citizens as well as persons who live with them in the same household,
 - iii. people with residence or habitual abode in EU / EEA countries or Andorra, Monaco, San Marino, the Vatican or Switzerland and people who live with them in the same household,
 - iv. entry in connection with other important events that can be planned in the family circle such as weddings, baptisms, birthday parties or the non-regular visit of the partner,
 - v. foreigners, if they have a visa D issued by Austria or a photo ID according to § 5 of the Official Seat Act - ASG, Federal Law Gazette I No. 54/2021,
 - vi. persons who are entitled to stay in Austria on the basis of a residence permit, a residence title or documentation of the right of

- residence in accordance with the Settlement and Residence Act, Federal Law Gazette I No. 100/2005, or the Asylum Act 2005, Federal Law Gazette I No. 100/2005 are,
- vii. persons who have a confirmation of the application pursuant to Art. 18 Para. 1 of the Agreement on the Withdrawal of the United Kingdom of Great Britain and Northern Ireland from the European Union and the European Atomic Energy Community (Withdrawal Agreement),
 - viii. members of the staff of diplomatic missions or consular posts and persons who live with them in the same household,
 - ix. employees of international organizations and people who live with them in the same household,
 - x. humanitarian forces,
 - xi. persons who are employed by a domestic regional authority or a domestic corporation under public law and whose place of employment is abroad or whose service is performed abroad, insofar as the activity of this corporation abroad is in the interests of the Republic of Austria,
 - xii. an accompanying person during entry for medical reasons,
 - xiii. people who enter the country for the purpose of performing a mandatory judicial or official obligation, such as summoning to court hearings

6. Entry for medical reasons

a. The entry of

- i. Austrian citizens,
- ii. persons who are subject to compulsory health insurance in Austria,
or
- iii. persons who have been granted a treatment agreement by an Austrian hospital for medical reasons that are particularly worthy of consideration,

is permitted without restriction if it takes place in Austria for the use of absolutely necessary medical services. Upon entry, a confirmation of the absolute necessity of using a medical service³ must be presented.

- b. People with their place of residence or habitual abode in Austria are allowed to re-enter the country without restrictions after having used essential medical services. Upon re-entry, a confirmation of the absolute necessity of using a medical service³ must be presented.

7. Commuter (does not apply to entry from virus variant areas according to 5.)

a. Entry

- i. as part of regular commuter traffic for work purposes,
- ii. as part of regular commuter traffic to participate in school and study activities, or
- iii. as part of regular commuter traffic for family purposes or to visit a partner

is possible with a medical certificate¹ or a test result of a molecular biological test (PRC, LAMP or TMA) or antigen test not older than 72 hours if arriving from Bulgaria, Croatia, Cyprus, Czech Republic, Estonia, France, Hungary, Netherlands, Poland, Slovenia, Sweden or outside from EU-/EEA-area (+ Switzerland, Andorra, Monaco, San Marino, Vatican). If arriving from remaining countries inside EU-/EEA-area (+ Switzerland, Andorra, Monaco, San Marino, Vatican) test must not be older than 7 days.

If the medical certificate or the test result cannot be presented, a molecular biological test (PRC, LAMP or TMA) for SARS-CoV-2 or an antigen test for SARS-CoV-2 must be carried out immediately, at least within 24 hours of entry.

- b. Entry from Germany is possible with a medical certificate, a test result, a vaccination certificate or a recovery certificate as per 3. If neither a medical certificate nor a test result, a vaccination certificate or a recovery certificate can be presented, a molecular biological test for SARS-CoV-2 or an antigen test for SARS-CoV-2 must be carried out immediately, at least within 24 hours of entry.

8. general exemptions, regardless of where these people come from, apply to (persons neither need molecular-biological test (PRC, LAMP or TMA) / Antigen-Test of SARS-CoV-2 nor have to start a quarantine):

- a. to maintain goods and passenger traffic (crews),

- b. exclusively for compelling reasons of animal care or for agricultural and forestry measures in individual cases,
 - c. in the context of the implementation of a professional transfer trip / a professional transfer flight,
 - d. in the imperative interest of the Republic of Austria,
 - e. transit passengers or the transit through Austria without a stopover, which is also the case with only essential interruptions,
 - f. the crew of a repatriation trip / a repatriation flight including the accompanying organs of the public security service,
 - g. for unforeseeable, urgent reasons that are particularly worthy of consideration in the family circle in individual cases (e.g. serious illnesses, deaths, funerals, births and the care of people in need of support in emergencies),
9. People who have to start a quarantine must present confirmation of the availability of suitable accommodation upon arrival and the costs must be borne. If no electronic registration has been made, the data must be entered in the registration form⁴ and confirmed with a personal signature.
10. children up to the age of 10 are exempted from any obligation to take a molecular-biological (PRC, LAMP or TMA) / Antigen-test of SARS-CoV-2 test
11. exemptions do not release passenger/crew from foreign immigration entry regulations (visa, ...)

Hygiene regulations

Version: 04.02.2021, applicable from 04.02.2021, further developments have to be considered

bus / train / ship: On board coaches / trains / excursion ships, a distance of at least 2 meter must be kept from people who do not live in the same household and a FFP2-mask without exhalation-valve (or similar standard) must be worn. If the distance of at least 2 meter is not possible due to the number of passengers and when boarding and alighting, an exception can be made.

aircraft: A FFP2-mask (or similar standard) covering the mouth and nose area must be worn on board aircraft.

The wearing of a mask does not apply to children up to the age of 6 and to persons who cannot be expected to wear the mask for health reasons. 6- to 14-year-old can use a community-mask instead of a FFP2-mask.

Checking the requirements

Upon arrival, entry requirements and hygiene regulations will be approved by Public Health Authorities (assisted by Police and Army). Existence of the respective reasons as well as documentation must be made credible on entry.

Collection of passenger data

Operators are obliged to collect contact details of passengers if departure point is an area listed on the homepage of the Federal Ministry for European and International Affairs for which a travel warning has been issued in connection with the occurrence or SARS-VoC-2. Details to be collected:

- ID of persons (full name, date of birth and nationality),

- departure and arrival time,
- border crossing point for entry into Austria,
- total number of people carried and

Data has to be stored for 28 days after arrival and made available immediately to Health Authorities on their request.
